What Is Voice Over Internet Protocol (VOIP)?

- Voice over Internet Protocol (VOIP) enables a consumer to use the Internet to talk to another person anywhere in the world. The call can be made using a regular telephone and an adapter or through a computer. The Internet is based on data transmission (called packet switching) which is much faster and more efficient than traditional telephone calling through local telephone companies' circuit switching networks.

Voice Over IP (VOIP) Availability & Offers In D.C. – as of January 2016

Vonage World - **\$27.99** per month (\$9.99 first three months) – unlimited local, long distance, and international calls to both landline and mobile numbers (includes ten countries). Customers must have high speed Internet service. Both services include standard calling features.

U.S. & Canada 400 - **\$12.99** per month – 400 anytime minutes of local & long distance in the US, Canada & Puerto Rico. Only **5.0¢** for each additional minute.
